

**Pima Federal Credit Union  
The Great Auto Loan Giveback  
Official Rules**

**Promotion Period**

Promotion begins on September 15, 2022 at 12:00am Mountain Standard Time (“MST”), and ends on December 15, 2022 at 11:59pm MST (the “Promotion Period”).

**Entry**

By entering the Promotion, each entrant accepts and agrees to be bound by these Official Rules. No purchase necessary to enter. Individuals who have an auto loan from Pima Federal Credit Union at the end of the Promotion Period will be automatically entered into a drawing to win a payoff of remaining balance on such loan, up to \$25,000. In addition, individuals who have an auto loan from Pima Federal Credit Union at the end of the Promotion Period will be automatically entered into a drawing to win twelve (12) months, or up to the number of months remaining on the loan term if less than twelve (12), of car payments, up to \$400 per month. Loan must be originated with Pima Federal Credit Union. Individuals may also enter by providing name, address, and phone number on a 3x5 card and mailing it to: Pima Federal Credit Union, 6860 North Oracle Road Suite 100, Tucson, Arizona 85704, Attn: Great Auto Loan Giveback; must be received before the end of the Promotion Period. One entry per person.

**Prizes**

There will be one (1) winner who will receive a loan payment made by Pima Federal Credit Union on a Pima Federal Credit Union auto loan, in the amount of the remaining loan balance up to a maximum of \$25,000.

There will be five (5) winners who will receive twelve (12) months of payments made by Pima Federal Credit Union on a Pima Federal Credit Union auto loan, up to a maximum of \$400 per month. If the remaining monthly payments total less than twelve (12) months, the winner will receive the aforementioned monthly payments equal to the number of monthly payments remaining on the loan.

Winner will be selected by random drawing from all eligible entries on or about December 16, 2022 and will be notified on or about December 16, 2022. Loan must be in good standing at time of drawing and prize notification. If winner does not have a Pima Federal Credit Union auto loan, prize will be awarded upon qualifying for and opening an auto loan with Pima Federal Credit Union, as long as loan closes on or before December 30, 2022.

Each winner will be notified by telephone and/or electronic mail and must complete all required paperwork and tax forms, and provide a valid U.S. issued unexpired photo identification by December 23, 2022 at 12:00pm MST; otherwise Pima Federal Credit Union will randomly select another winner. Winner is responsible for all applicable federal, state, and local taxes. The prize cannot be substituted, transferred, or exchanged for any other award, amount, cash value, or benefit. Odds of winning depend on the number of entries received.

**Conditions**

The drawing is void where prohibited or restricted by law and is subject to all federal, state, and local laws and regulations. Winner agrees to the use of their name and likeness in publicity without notice or any additional compensation, except where prohibited by law. By entering this promotion, the winner acknowledges that Pima Federal Credit Union has the right to publicize and broadcast their name, voice, and likeness, the fact that they won, and all matters incidental thereto. By entering this promotion, each entrant releases Pima Federal Credit Union and its respective directors, officers, employees, agents, and subsidiaries from any and all liability, claims, causes of action, suits, and demands arising from or in connection with its lawful actions in conducting the promotion. ### **Eligibility**

Open to all individuals who qualify under the entry rules above. Directors, officials, and employees of the Credit Union, and their immediate families (parents, children, siblings, and spouse) are not eligible. Must be 18 years or older at the time of entry.
